# CLUB RULES

# Club Rules

- **Dress Code**

Proper dress for Men and Women is required. Shorts and skirts may be no more than three inches above the knee. Cargo shorts are allowed, however, those that are ripped, frayed or badly faded will not be permitted. The wearing of hats is prohibited in the dining room. Jeans are allowed in the Clubhouse and Family Activity Center, but not on the golf course or driving range. Men must wear a collared or mock neck golf shirt. T Shirts are not permitted on the golf course, driving range or in the clubhouse. Shirts must be tucked in at all times while on property.

- **Cell Phone Policy**

The use of cell phones is not permitted in the dining room. Cell phones are not to be used during tournament play. Members need to be courteous and respectful while using cell phones on property. Cell phones must be set to vibrate or silent mode at all times.

- **Smoking Policy**

Smoking and smokeless tobacco is prohibited in the Clubhouse and Family Activity Center.

- **Member Purchases**

All golf, pool, and food and beverage charges shall be billed directly to the Member's account. Golf shop merchandise and guest green fees may be paid by credit card or billed directly to the Member's account

- **Service Charges**

Food and beverage charges will be subject to an automatic 18% service charge.

- **Lost and Found**

The Club will not be responsible for the loss of or damage to lost and found property.

- **Shoe Service**

Members are to change shoes and dress in the locker room only. Shoe service is available. Please see the locker room attendant for service.

- **Insufficient Funds**

There will be a \$25 charge for any returned checks.

- **Member Statements**

Member's statements are mailed on the first business day of every month.

Member's accounts will be subject to a 1.5% service charge if the outstanding balance is not paid within thirty days from the statement date.

Club privileges will be revoked to Members whose account is not paid within 60 days, and Member's names will be posted in the clubhouse. Past due accounts will continue to be subject to a 1.5% service charge on all outstanding balances.

## Club Rules (Continued)

- **Donation Policy**

Sagamore Club will provide a 4-some donation when there's a participating Member purchasing 2 rounds. The Member will be billed a \$60 fee for each round then the recipients will be required to pay a cart fee at check-in. Donation requests must go through a Member who then gets it approved through the General Manager. Each Member is allowed to request one 4-some per year. Recipients will be required to present the donation certificate upon check-in. A 4-some donation is valued at \$480 which is the unaccompanied rate. All unaccompanied guests will be required to take a forecaddie.

- **Code of Conduct**

The Club reserves the right to terminate a membership for inappropriate conduct or behavior of a Member or his/her guest. Inappropriate conduct and behavior includes foul language, verbal or physical threats, club throwing, cart damage, disrespect to the golf course, failure to check in for golf before starting, and harassment toward fellow Members and employees.

A member that is persistently displaying bad behavior will first receive a warning from the General Manager for the first offense, the second offense requires a letter from the Advisory Board, and the third offense they will be punished with whatever the Advisory Board recommends.

- **Leave of Absence Policy:**

Every Member is entitled to take a **one-time** leave of absence for a 12-month period. In order to be eligible to take a leave of absence your account must be paid current. During the 12-month leave of absence period, you are responsible to pay \$50 per month and will not have access to the Club as a Member or a guest. The only exception is if you are invited to a private party where the bar and dining room has been reserved and the Club is closed to the Membership. You will not be responsible for the quarterly food and beverage minimums.

After fulfilling the 12-month leave of absence period you will then resume your membership per the Membership Plan and be billed the current applicable dues in the Membership category type that you started the leave of absence. If you decide to resume the Membership before the end of the 12-month leave of absence period, you'll then be responsible for paying the difference between the \$50 leave of absence fee and the normal monthly dues for all months on leave of absence.

- **Membership Category Transfer:**

Every Member is entitled to take a **one-time** "Membership Category Transfer". A Member may transfer their Membership to another category for a minimum of a 12-month period. At the end of the 12-month period the Member may chose to go back to their original membership category. A member may transfer their

membership from Social to Golf by satisfying the current Golf Initiation Fee or a Golf Member may transfer to a Social Member as long as they have satisfied the Social Initiation Fee.

The Member must wait a minimum of 12 months to transfer back to their original membership category but can go longer than 12 months if they choose. If a Golf Member transfers to a Social Membership and wishes to resume their Golf Membership before the end of the 12-month period, they will be responsible for paying the difference between the Social and Golf dues during the months the Membership was transferred.

If a Social Member transfers to a Golf Member and wishes to resume their Social Membership before the end of the 12-month period, they will be still responsible for paying the “Golf Dues” through the 12-month period.

Members will be billed the applicable dues and fees according to the “Membership Rules” and “Membership Fees and Billings” associated with their Membership Category.

## **Golf Rules**

- **Practice Tee**

The practice tee will open ½ hour before the first tee-time. Please note that the practice facility will close one hour prior to sunset in order for the staff to clean and pick the practice facility on Wednesday and Sunday evenings.

Please note that the north tee is to be used when practicing for an extended period of time and the south tee should be used for warming up.

- **Tee Reservations**

All golfers are encouraged to call ahead for tee times so the staff can anticipate their arrival. Members may reserve tee times for one foursome up to fourteen days in advance. Members are encouraged to identify the other names of golfers playing in the group. In order to maximize the ability for members to receive priority tee times on weekends and holidays until 10:30 a.m. each member may only bring one guest. Requests for tee times during this restricted period with more than one guest need to be made in advance and a member can only be granted permission through the Head Professional.

- **Guest Rounds Limitations**

Each guest is limited to five rounds of golf per calendar year, not including Member-Guest events.

- **Cancellation Policy**

Tee times must be cancelled twenty-four hours in advance or the Member will be responsible for the charges associated with the tee time.

- **Cancellation Policy for Club Tournaments**

The following is the course of action that will be taken if a member does not provide at least 24 hours advance notice that they cannot participate in an event that they have previously sign up for AND has put the golf shop in a position that they

cannot account for a missing player AND has put the person's team at a substantial disadvantage:

1<sup>st</sup> Offense – Verbal Warning and entry forfeited

2<sup>nd</sup> Offense – Letter sent, entry forfeited, pay for all player's entry fee in the group

3<sup>rd</sup> Offense – Entry forfeited, pay for all player's entry fee in group, letter sent suspending member from club tournaments for 12 months

Extenuating circumstances and the reason for the no-show will be considered on a per case basis at the discretion of the Golf Professional.

- **Check-In**

All golfers must register in the golf shop prior to play. It is necessary to sign all golf and merchandise receipts.

- **Pace of Play**

Optimal pace of play for 18-holes in no more than four hours and fifteen minutes. If any group has more than one clear hole in front of them, the following group must be allowed to play through. The professional staff has the right to require groups of 4 walkers that complete the first 9 holes in over 2 hours and 20 minutes to all take a golf cart on the back nine.

- **5-somes**

Groups of 5 players are not permitted to play together between 11:30am--1:30pm on Wednesdays and Fridays and before 10:30am on weekends and holidays. 5-somes are allowed on the golf course at any other time provided that they do not hold up play behind them and play in 4 hours and 15 minutes.

- **Care of the Course**

Please be sure that all ball marks on greens are repaired and that all footprints and holes in the bunkers are raked smoothly.

Divots should be replaced after each full swing in the fairway only.

The Superintendent and Head Professional will determine the cart path policies for each day.

- **Golf Cart Driving Policy**

The first time a member violates our cart driving policy the individual will receive a verbal warning from the Head Golf Professional or General Manager. The second violation will be a written notification of the violation from the General Manager. The third violation will result in the suspension of golf cart driving privileges for a month. A fourth and subsequent violation within 6 months of the end of a suspension period will result in the revoking of your cart privileges indefinitely.

- **Practice on the Course**

Practice is not permitted on the golf course.



## Golf Rules (Continued)

- **Peak Tee Time Cancellation Policy**

NEW Tee Time Cancellation Policy

We are enacting a new policy with regards to failure to cancel a peak tee time (before 10:30am on weekends & holidays; between 11:30-1:30pm on Fridays). Failure to cancel an unused peak tee time will result in the following penalties:

**First Offense** – Written (Email) Warning

**Second Offense** – Your account will be charged a \$100 penalty fee

**Third Offense** – You will be unable to book a peak tee time for 1 month

**Fourth Offense** – You will be unable to book a peak tee time for the rest of the season

Additionally, we are asking members to give 18 hours advance notice when cancelling a peak tee time. There are extenuating circumstances that we will definitely take into consideration (a poor weather forecast being one of them) with regards to this. However, as you can imagine, we have numerous other members looking to play in the morning on the weekends and during lunchtime on Friday to not have members cancel a tee time that they are not planning to use in a respectable amount of time. In short, please be aware of tee times that you make at all times, even more so during these peak times.

- **Guest Purchases Policy**

Guests may purchase merchandise and pay for their guest fees by credit card.

- **Golf Outings**

The course is reserved on Mondays for the maintenance staff and/or Member/Management sponsored golf outings. From time-to-time the Club can offer to host a golf outing on a non-Monday; usually Tuesday or Thursday. If an outing is hosted on a non-Monday then the course will be open for play to our Members on the Monday of that week.

- **Club Tournaments**

Tee times will be reserved before the season starts for all scheduled tournaments including the major events such as the Member-Guest, the Member-Member, and the Club Championships.

- **Junior Tee Time Policy**

Junior golfers can reserve tee times on the day of play. Juniors may be included in the tee time reservations when playing with their parents.

- **Junior Play Policy**

Junior golfers 16 and older may play golf at all available tee times.

A parent must accompany junior golfers 10 to 15 years of age unless certified by the Head Professional. Junior golfers under 10 years of age should not be

on the course during peak times. Please call the Golf Shop for tee-time availability.

Junior golfers may bring guests based on course and tee time availability. Junior guests are subject to guest fees and policies.

Adult groups have priority over “junior only” groups on the first tee.

- **Unaccompanied Guest & Outside Group Policies**

The Club will have up to two unaccompanied tee times available each day Tuesday through Friday.

The Club reserves the right to eliminate unaccompanied tee times on certain days of the week due to tournaments or levels of play.

All unaccompanied tee times must be reserved through a Member, the Head Professional, or the General Manager.

A Member may sponsor only one of the unaccompanied tee times available each day.

The Club reserves the right to sponsor media, golf writers, and Golf Digest panelists.

Tee times for guests will be granted based on availability and activities taking place at the Club.

Outside groups and tournaments will be allowed on Mondays and must be sponsored by a Member or Club Management.

Monday sponsored events can be reserved up to twelve months in advance and must be guaranteed for a minimum of forty-eight players. Groups of less than forty-eight players can be reserved but they are subject to cancellation by the Club based on demand from a larger group.

The Club reserves the right to host non-Monday outing events up to 288 players per event.

- **Handicap Enforcement Policy**

To protect the Sagamore Membership all members will be required to post all 9-hole and 18-hole scores within “3” days of playing. The professional staff will post all tournament and league scores.

Tournament scores that will be posted include:

- Ladies Member Guest
- Senior Club Championship
- Men’s Club Championship

- Couples Club Championship
- Ladies Club Championship
- Team Match Play
- Individual Match Play
- Wednesday Ladies League

➤ Wednesday Men's Club

Each Monday, The Professional Staff will then select 20 random members who played at least one time the previous week and verify that scores have been posted. The Professional Staff will cross reference the weekly tee sheets with our handicap software to ensure all scores are being posted. If you are a member and

see someone that does not post a score, please notify the Head Golf Professional or report the member at [SagamoreHandicapCommittee@Gmail.com](mailto:SagamoreHandicapCommittee@Gmail.com) and he will added to the list of names that will be checked.

Members will get a one-time grace period on posting scores. After that, a score of 72, or the lowest score from the past 12 months, will be posted from the professional tees as a penalty score.

## **Family Activity Center Rules & Operations**

- **Exercise Programs**

The club offers exercise classes throughout the week. Please call the Family Activity Center for the class schedule as classes are evaluated every two months. Classes are free of charge to members. Classes are available to accompanied guests of a member for a fee to be determined by club management.

- **Health Services & Programs**

Personal training is available by appointment. Please call the Club for details and reservations.

- **Age Regulations**

Children under 16 years of age are not permitted to use the fitness center without adult supervision.

- **Child Care**

Child-care is available by reservation. Hours of operation will depend on the season and on demand. Please call the Club to make your reservation.

Children will be accommodated for a maximum of four hours and parents are required to stay on the premises.

Members will be charged \$5 per child per hour and guests' children are \$7 per child per hour.

## **Tennis Rules & Operations**

- **Dress Code**

Proper tennis attire is required at all times.

- **Reservation Policy**

Reservations are not necessary.

Please call ahead to check availability.

- **Tennis Lessons**

Tennis lessons will be available during the summer. Please call the Club for more details.

## Pool Rules & Operations

- **Opening / Closing Dates**

The pool will be open from Memorial Day Weekend through Labor Day Weekend.

- **Dress Code**

Proper swimming attire is required at all times. Shirt and shoes are required to be worn in the Family Activity Center at all times.

- **Guest Policy**

Members are allowed up to four guests per day and may bring the same guest up to ten times during the pool season.

Guests include anyone not under the membership plan.

A nanny or babysitter may bring children of Members to the pool at no charge as long as the Member has provided written notice prior to their arrival.

- **Guest Fees**

The daily guest fee is \$5 per guest.

- **Age Regulations**

An adult must accompany anyone under ten years of age.

- **Daily Pool Clearing**

The pool will be cleared for ten minutes every hour for safety and hygiene.
